#### **ABOUT THE BOARD**

The Isle of Wight Safeguarding Adult Board (SAB) works in partnership with local and regional organisations to safeguard people with care and support needs from abuse and harm.

The Board has three statutory partners who are the Isle of Wight Council, Hampshire & IoW Integrated Care Board and Hampshire & IoW Constabulary. These three agencies make up the Executive Group, who have oversight and governance of the SAB and its activities.

This year has seen the transition to a new Independent Chair, Dr Paul Kingston and the introduction of Laura Rice as the Board Manager and Andrew Milford-Wood as Snr Admin. The 'new look' team are eager to move forward and support delivery of the Board's objectives.

The SAB has three subgroups who deliver work on behalf of the Board:

- The Safeguarding Adult Review Subgroup triage and assess referrals to commission reviews that may identify local multi-agency learning.
- The Workforce Development Subgroup supports the identification, commissioning, and delivery of multi-agency learning.
- The Quality, Assurance and Performance Subgroup reviews local data and identifies themes for audit and scrutiny to provide assurance that the learning has been embedded.



If you need support to manage a risk out of normal office hours, please contact the emergency duty team on (01983) 821105.



# **SAFEGUARDING ACTIVITY 2023-2024**









### SAFEGUARDING ADULT REVIEWS (SAR) SUBGROUP

A statutory function of the SAB is to carry out Safeguarding Adult Reviews (SARs). The purpose of a SAR is to gather the facts about a case, review how agencies worked together and to identify lessons and improvements which can be made to improve outcomes for Island residents who have care and/or support needs and may be at risk of or experiencing abuse or neglect.

#### **Key Activity**

The SAR subgroup continued to meet monthly and received 5 new referrals, with 2 referrals carried over from previous years, of which 1 had progressed to a statutory SAR in partnership with Southampton City Council. A shared learning brief has been created to capture the key findings from the report and distributed to partner agencies and published on the SAB website. In February 2024, the SAR Subgroup facilitated a multi-agency learning workshop to identify any learning that could be applied to prevent future deaths. The workshop was well attended and allowed an opportunity for professional reflection. The feedback from those attended was positive and a learning brief has been created and circulated to all partner agencies.

#### **Key Challenges**

Analysis of referral data has shown that there are significant delays to referrals being submitted to the SAR subgroup for consideration. This then delays the identification and implementation of learning.

#### **Future Focus**

To support the identification and implementation of learning, a task & finish group is being considered to review local unexpected deaths. This will offer statutory partners an opportunity to review agency involvement and identify potential referrals at an earlier stage. The SAB Business Unit is also reviewing its processes to ensure information is collected in a timely manner and presented to the Subgroup in a clearer and more concise fashion.



#### **QUALITY.ASSURANCE & PERFORMANCE SUBGROUP**

#### **Key Activity**

Despite the challenges with delivering Board activity in 2023/24, the Quality Assurance and Performance subgroup have commenced a review into the application of the Multi-Agency Risk Management Framework (MARM) and combined this with a review of how services engage with individuals who 'do not attend'.

#### **Key Challenges**

Engagement from individuals with lived experience has been a particular challenge, the ability to identify case studies to form part of the review has limited the quantitative data available to the subgroup to make recommendations.

#### **Future Focus**

The Board will be engaging with the newly commissioned Help and Care service to identify individuals with lived experience and will be more proactive in speaking to individuals during their safeguarding journey rather than retrospectively.

A review of the audit process will also be completed with an anticipated move away from traditional surveys and questionnaires. The Board's Business Unit will be leading on a conversational approach to collating data and experiences.

#### WORKFORCE DEVELOPMENT SUBGROUP

#### **Key Activity**

The subgroup, combined with the IoW Childrens Safeguarding Partnership, developed the annual learning needs analysis to identify key themes for learning and development opportunities.

Members of the Board completed enhanced training from Social Care in Excellence to provide detailed learning on Safeguarding Adult Reviews, which will better inform the work of the Safeguarding Adult Review Subgroup.

#### Key Challenges

A lack of operational oversight during 2023/24 has meant a reduced learning and development offer from the SAB.

#### **Future Focus**

Consideration and development of a learning and development programme which provides value for money whilst meeting strategic and organisational needs. In addition, the development of a Safeguarding Adults Conference which can be combined with local learning from Safeguarding Adult Reviews to maximise awareness.



#### **4LSAB ACTIVITY**

The Isle of Wight Safeguarding Adult Board works in partnership with our regional partners in Hampshire, Southampton and Portsmouth to deliver shared priorities and objectives.

#### 4LSAB Policy Subgroup

With the support of partners, the subgroup has revised and created 6 multi-agency policies, however, the volume of work and time constraints on partners remains a challenge. Key documents for review in 2024/25 include the Safeguarding Concerns Guidance and Safeguarding in Prisons and Approved Premises.

#### **4LSAB** Housing Subgroup

Reviewing SARs, sharing best practice and learning from providers to help prevent further similar issues from occurring. Ensuring understanding of how and when to raise a safeguarding concern. Ensuring attendance at meetings from relevant partners due to busy work schedules and ensuring that the meetings provide value to their organisations and the housing sector.

#### 4LSAB Fire Safety Development Group

The 4LSAB Fire Safety Development subgroup has continued to review and share learning from serious fire incidents, to ensure that effective inter-agency processes, procedures and preventative practices are in place. The subgroup has also reviewed the delivery of Safe and Well visits to ensure effective partnership working and risk mitigation to individuals and families.

#### 4LSAB Health Subgroup

The subgroup has continued to successfully review health related priorities as identified by the 4LSAB and health partners, which includes completing a review of how health organisations raise safeguarding concerns with adult social care. As with other subgroups, high workloads have impacted on partners' availability.



#### **4LSAB BIENNIAL SELF AUDIT**

In January 2024, the 4LSABs requested that partners across the region complete a self-audit of their safeguarding processes and procedures to identify any gaps and areas for development.

The results of the audit identified several themes where confidence was low. As a result, several actions for the 4LSABs have been identified which will be incorporated into the work of the Policy Subgroup.
